NOTICE is hereby given to the electors of **Membertou** that a poll will be held to vote on **Membertou Family Homes Law**, on Friday, the 29th and Saturday the 30th day of April, 2016, from nine o'clock (9:00) a.m. until eight o'clock (8:00) p.m. at the location listed below:

AND TAKE NOTICE THAT voting will be conducted in person by secret ballot, by mail-in ballot and by Electronic Voting;

AND TAKE NOTICE THAT all Members of Membertou who will be 18 years of age as of the 29th of April, 2016 and are Eligible Voters;

AND TAKE NOTICE THAT all Eligible Voters who wish to vote electronically must register to vote by visiting the following website:

- After registering, you will receive an email with instructions on how to vote electronically and the PIN number they will need to log in.

AND TAKE NOTICE THAT Eligible Voters who wish to vote by mail-in ballot, who haven't already received one, must make a written request to the Electoral Officer for a mail-in ballot package no later than twenty-eight (28) days prior to the first (1st) Voting Day;

AND TAKE NOTICE THAT Eligible Voters who wish to vote in person must attend during one of the following Voting Days at one of the following locations to cast a secret ballot:


